$$S_T = S_0 e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)T + \sigma\sqrt{T}Z}$$

$$S_h = S_0 e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)h + \sigma\sqrt{h}Z_1}$$

$$S_{2h} = S_h e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)h + \sigma\sqrt{h}Z_2}$$

⋮

⋮

$$S_{nh} = S_{(n-1)h} e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)h + \sigma\sqrt{h}Z_n}$$

↓

$$S_{nh} = S_0 e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)h + \sigma\sqrt{h}\sum_{i=1}^n Z_i} = S_0 e^{\left(\alpha - \delta - \frac{1}{2}\sigma^2\right)h + \sigma\sqrt{T}\left[\frac{1}{\sqrt{n}}\sum_{i=1}^n Z_i\right]}$$

where

$$\frac{1}{\sqrt{n}} \sum_{i=1}^n Z_i \sim N(0, 1)$$
